Another troubling bill is HB 1084 which challenges what teachers can teach, and HB 4035 regarding transgender discrimination. Eileen is excited to help get our organization focused and organized for the upcoming legislative session so that we can effectively advocate for the arts across the state of Georgia.

Allan Vella, President & CEO, Fox Theatre

Allan C. Vella is the President and CEO of the Fox Theatre, Inc. in Atlanta, Georgia, a position he has held since June 2006.

A graduate of the University of Iowa with a BA in Liberal Arts and Arts Management, Vella served as the Director of the Student Commission on Programming and Entertainment while at Iowa.

Vella has worked professionally in the Facility Management field since 1986, managing theatres, arenas, amphitheaters, and exhibition facilities. His experience spans a wide range of events, including NCAA

Tournaments, MLB, NHL, fine arts, corporate events, concerts, Broadway, and Presidential visits, to name just a few.

As the President and CEO, Vella is responsible for overseeing all operations that make up the Fox Theatre, as well as programming for the facility. The Fox Theatre averages 200-250 performances and hosts over 600,000- 700,000 guests annually - offering an impressive range of events from rock concerts to Broadway, ballet, comedy, and movies. Under Vella's direction, the 4,665-seat Fox Theatre has been consistently ranked in the top three non-residency theatres in North America for gross ticket sales by industry trade magazines Pollstar, Billboard, and VenuesNow. In addition, the Fox Theatre was named the 2019 & 2017 International Entertainment Buyers Association Theatre of the Year, as well as declared a Top Stop of the Decade by VenuesNow for the highest number of tickets sold, and Billboard Magazine ranked the theatre the 2nd highest grossing venue worldwide under 5,000 seats, and Pollstar ranked the Fox 3rd worldwide for ticket sales for its category. Vella was named one of VenuesNow 2019 All-Stars, and also in 2021, Vella was named one of Atlanta's top 500 leaders by Atlanta Magazine. In 2014 Vella was nominated as one of Atlanta's most admired CEOs by the Atlanta Business Chronicle.

Prior to joining the Fox Theatre, Vella worked for SMG, the world's largest facility management company. His positions included that of General Manager for Ford Park in Beaumont, Texas, where he operated a 227-acre facility consisting of a 16,000-seat amphitheater, a 10,000-seat arena, an exhibit hall, and a State Fair Grounds. Vella's first assignment with SMG was at the Dow Event Center in Saginaw, Michigan, where he oversaw the securing of naming rights, privatization, renovation, and operation of a 7,200-seat arena and a 2,300-seat theater.

Other notable experience for Vella includes thirteen years with Olympia Entertainment in Detroit, Michigan, where he held influential positions such as Senior Director and General Manager of The Fox Theatre, Detroit. Director of Merchandising for the Detroit Tigers, Detroit Red Wings, Detroit Zoo, and parent company Little Caesars Pizza and Executive Director of the Glens Falls Civic Center in Glens Falls, New York.

Vella is a Member of the International Association of Venue Managers, a graduate of IAVM's Venue Management School, a member of the IAVM Performing Arts Committee, a member of Georgia Arts and Culture Venues Coalition, the Broadway League, a Board Member-Atlanta Convention and Visitors Bureau, Board Member-Midtown Alliance, Board Member- Georgia Tourism Foundation, Rotary International as well as Variety of Georgia, a children's charity. He and his wife Nicole have three children and reside in Decatur, Georgia.
